Who is responsible for your data?

It is possible that personal user data may be collected through a cookie. HOTELVERSE TECHNOLOGIES, S.L., with C.I.F. B-09798729, and registered office at Carrer Cirugians i Barbers, 25, Edificio A, Planta 1 - 07009 Palma de Mallorca (Spain), is responsible for the collection and processing of this data.

What are cookies?

Cookies are small files that are installed on the user's computer when the user accesses a website. Cookies allow, among other things, to store and retrieve information about the browsing habits of a user or their equipment and, depending on the information they contain and the way they use their equipment, depending on the type of cookie and the information they collect, they can be used to recognise the user.

Types of cookies

a) Depending on the entity that manages the cookies:

- Own cookies: these are those that are sent to the user's device or terminal from our equipment or domain, and are also managed by ourselves, as owners and editors of this website.
- Third-party cookies: are those that are sent to the user's device or terminal from a computer or domain that is not managed by ourselves, but by a third party that will process the information obtained through the cookies.

b) Depending on the shelf life:

- Session cookies: these are cookies that collect and store data when the user accesses the website and cease to exist once the user leaves the website.

- Persistent cookies: these are cookies that have a duration determined in time by the data controller. The retention time can vary from a few minutes to several years. They are used to save and retrieve certain parameters each time the user visits the website.

c) According to their purpose:

- Technical cookies: these are essential and strictly necessary for the correct functioning of the website and the use of the different options or services that we offer. For example, those used to maintain the session, manage response time, performance or validation of options, use security elements, share content with social networks, etc.

- Personalisation cookies: these are cookies that allow the user to specify or personalise certain features of the website. For example, defining the language, regional configuration or type of browser.

- Analysis cookies: these allow us to monitor and analyse user behaviour on our website in order to create browsing profiles and find out user preferences. They are usually used to measure user activity in order to improve the service we offer based on the results we obtain. For example, an analytical cookie would be used to monitor the geographical areas of greatest interest to a user, which is the most popular product or service, etc.

- Advertising cookies: these are cookies that allow us to manage advertising space on websites.

- Behavioural advertising cookies: these cookies enable the management of advertising spaces on our website. The function of these cookies is to store information on user behaviour on our website, in order to subsequently display personalised advertising.
